



## **FOR INTERNATIONAL SHORT PROGRAMS (ONE QUARTER)**

### **IMPORTANT INFORMATION FOR STUDENTS APPLYING FOR THE SHORT PROGRAMS**

**Eligibility:** Application to most UCSC Extension short programs is open to international students who have the following minimum qualifications:

1. At least two years of college experience
2. English Proficiency score: iBT TOEFL 70, IELTS 6.0, or equivalent and accepted qualifications.  
Note: English Waiver may also apply if you have at least two years of recent study or completed a degree at university or college from an English speaking country.

Successful applicants are issued a letter of admission to UCSC Extension along with a signed I-20 (Certificate of Eligibility) to support an application for a student visa at U.S. Embassies or Consulates or a change of status in the U.S.

**Academic Requirements:** International students must enroll in a minimum 12 units of classes every quarter with passing grades in these classes. Only three units of the required 12 units may be taken in an online format.

**Optional Practical Training (OPT):** OPT is NOT available for the one-quarter short programs. Programs shorter than nine months do not qualify for practical training.

**Application Processing Time:** The completed application form and supporting documents can be emailed to [extensioninternational@ucsc.edu](mailto:extensioninternational@ucsc.edu). Normal processing time for an application is three to five business days after submission. If any additional information is required, students are notified via email when their application is being processed.
